THE CAMPUS KITCHENS PROGRAM COORDINATES FOOD DONATIONS, PREPARES AND DELIVERS MEALS TO AREA COMMUNITY SERVICE AGENCIES, TEACHES BASIC FOOD PREPARATION AND CULINARY SKILLS TO THE UNEMPLOYED AND PROVIDES SERVICE LEARNING OPPORTUNITIES FOR STUDENTS. THERE ARE FIVE KITCHENS OWNED AND OPERATED UNDER THE CAMPUS KITCHENS PROJECT (CKP). THEY ARE LOCATED AT ST. LOUIS UNIVERSITY, NORTHWESTERN UNIVERSITY, MARQUETTE UNIVERSITY, GONZAGA UNIVERSITY AND UNIVERSITY OF MASSACHUSETTS BOSTON. IN ADDITION, THERE ARE TWENTY-NINE AFFILIATE KITCHENS LOCATED AT VARIOUS UNIVERSITIES ACROSS THE UNITED STATES. DURING 2014, CKP ENGAGED MORE THAN 16,000 STUDENTS WHO HAVE PROVIDED MORE THAN 65,000 VOLUNTEER HOURS RECYCLING APPROXIMATELY 155,000 POUNDS OF FOOD, WORKING IN THE KITCHEN AND DELIVERING MORE THAN 280,000 MEALS.
